## 2. HAZARDS IDENTIFICATION

## 4. FIRST AID MEASURES

- Eyes :** Rinse immediately with copious amounts of water for at least ten minutes, holding the eyelids open and obtain immediate medical attention.
- Inhalation :** Remove from source of exposure and obtain immediate medical attention.
- Skin :** Wash skin immediately and thoroughly with water. Remove contaminated clothing. Obtain medical attention if symptoms develop.
- Ingestion :** Remove product from mouth, give the casualty a small quantity of water to drink and obtain immediate medical attention. Do not induce vomiting.

## 5. FIRE FIGHTING MEASURES

NON FLAMMABLE - In the event of a fire due to other causes the product is compatible with water, foam, carbon dioxide and dry powder extinguishers. May evolve toxic fumes if involved in a fire. Firefighters should wear self contained breathing apparatus and suitable protective clothing including gloves and eye/face protection.

## 6. ACCIDENTAL RELEASE MEASURES

Wear full protective clothing including gloves and eye/face protection. Hose away with plenty of water diluting to at least 1% w/v (10 g/litre) unless this would contaminate a water course or vegetation, in which case either collect, dilute as earlier and pour down wastewater drain (foul sewer) or absorb onto dry sand or similar material and dispose of safely as commercial waste.

## 7. HANDLING & STORAGE

Avoid contact with skin, eyes and clothing. Wear suitable gloves and eye/face protection. Always ensure good ventilation when using this product. Do not breathe vapour or spray mist. Do not mix with any other chemicals other than as advised by your Diversey representative. Store upright in original closed containers in a cool place.
