The ingredients are present in non-hazardous concentrations., A063 is a Cosmetic Product which contains: Aqua, Caprylyl/Capryl Glucoside, Glycerin, Cocamide DEA, Chlorhexidine Digluconate, Allantoin, Lactic Acid, Benzyl Alcohol, Chloromethylisothiazolinone, Methylisothiazolinone, Triethylene Glycol, Propylene Glycol, Magnesium Chloride, Magnesium Nitrate.

4.1. Description of first aid measures

Inhalation
